GENERAL RECOMMENDATIONS

FOR USE AS A NUTRITIONAL SPRAY

Uniformly apply the suggested rates of TECH-SPRAY in the following amounts of water per acre.

	Dilution	Foliar Rate	Application Timing
Field, Row & Vegetable Crops	By air: 3-20 gal	1 pt - 2 qts	Apply every 2-4 weeks as needed, starting pre-bloom
	By ground: 5 gal min		
Tree & Vine Crops	By air: 10 gal min	1 pt - 4 qts	Apply every 2-4 weeks as needed, starting pre-bloom to post harvest
	By ground dilute: 100-500 gal		
	By ground concentrate: 25-100 gal		
In oil sprays: use 1-4 pints per 100 gallons		Minimum dilution rate: 1 quart per 3 gallons.	

COMPATIBILITY: This product is compatible with most crop protection materials. A compatibility test is recommended when using new combinations. Do not mix with lime, fixed copper fungicides, or TPTH.

SOIL APPLICATIONS: For all crops: 1-4 qts per acre as needed. Do not apply with phosphate or sulfate fertilizer products. Any previously applied phosphate or sulfate fertilizer should be thoroughly flushed from fertigation equipment prior to application of TECH-SPRAY. Apply TECH-SPRAY products slowly into fertigation equipment in the early part of the water application.
